

# SuperLife KiwiSaver scheme

## SuperLife Income Fund

This is a replacement fund update dated 21 December 2023, which replaces the previous fund update dated 30 October 2023. The market index return data in the "How has the fund performed?" section, including the annual return graph, has been updated to show correct market index returns over the relevant periods.

### Fund update for the quarter ended 30 September 2023

This fund update was first made publicly available on 21 December 2023.

### What is the purpose of this update?

This document tells you how the SuperLife Income Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Invests in income assets and is designed for investors that want an investment in New Zealand and international fixed interest. Negative annual returns may occur once in every 7-10 years on average.

### What are the risks of investing?

#### Risk indicator for the SuperLife Income Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher

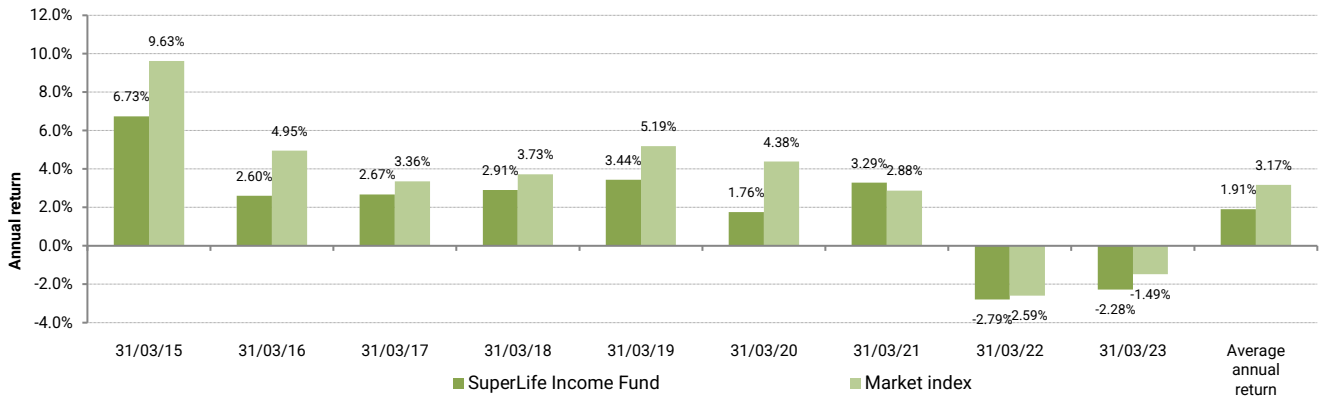
### How has the fund performed?

## Annual return graph

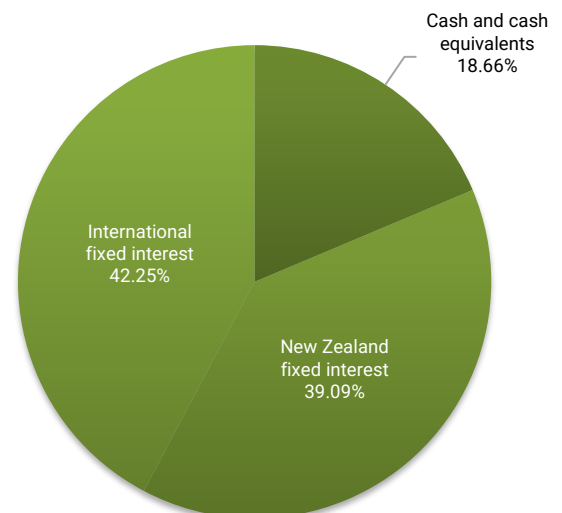
## Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$118 (that is 1.18% of Jess's initial \$10,000). Jess paid other charges of \$30. This gives Jess a total return after tax of \$44 for the year.

## Currency hedging

As at 29 September 23 the fund's exposure to assets denominated in foreign currencies was 41.67%, of which 100.00% was hedged. This means the fund's unhedged foreign currency exposure was 0.00% of the net asset value of the fund.
