What is the purpose of this update?

What are the risks of investing?

Risk indicator for the Global Property Fund




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$2,086 (that is -20.86% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$2,146 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100% (although the actual hedging level may differ from this because of cash flow and market movements). As at 30 September 2022, 104.76% of the fund's foreign currency exposure was hedged.

- 1 The fund charges will be increasing by 0.10% per annum of the fund's net asset value, from 12 December 2022
- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. This may be shown as 0.00% due to rounding.
