What is the purpose of this update?

What are the risks of investing?

Risk indicator for the Overseas Shares Fund

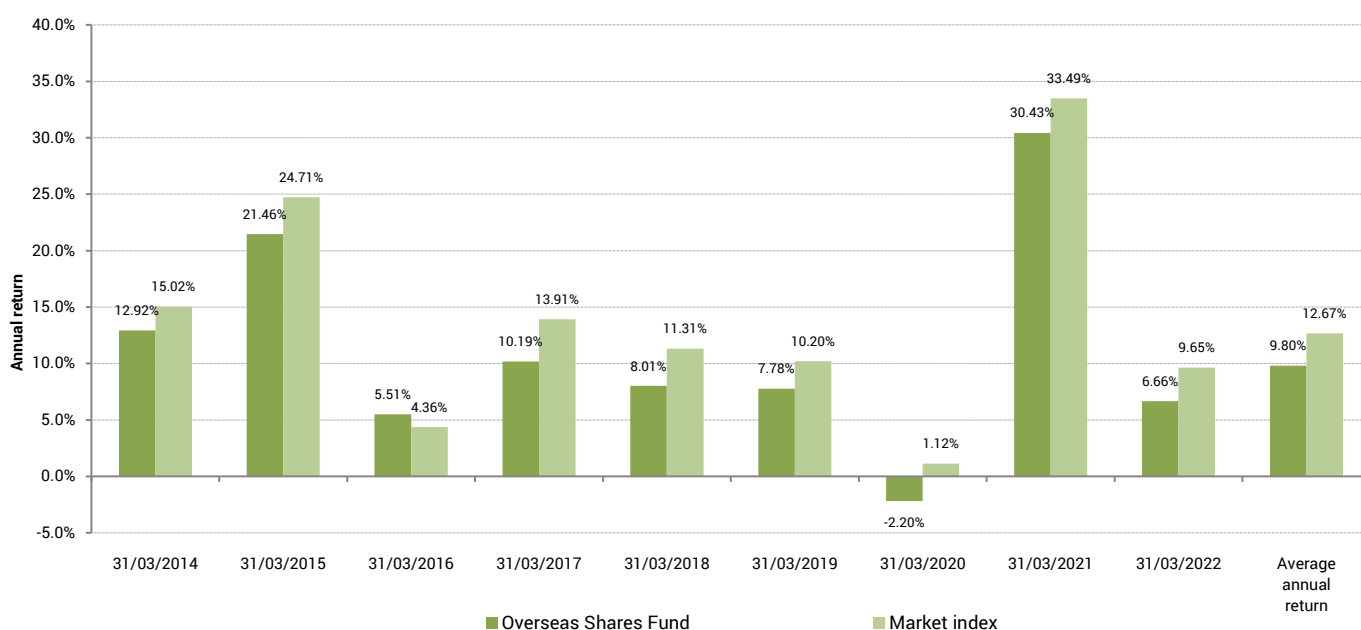

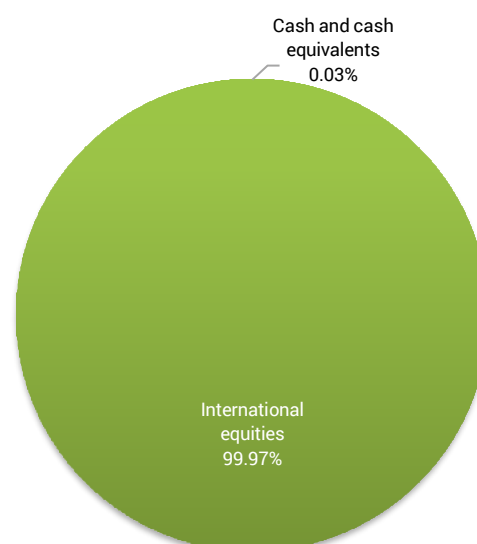
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$671 (that is -6.71% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$731 for the year.
