What is the purpose of this update?

This document tells you how the Overseas Nongovernment Bonds Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in international bonds and is designed to reflect the return (before tax, fees and other expenses) on international non-government bond markets of developed economies.

The market index annual return is based on the annual return of the Bloomberg Global Aggregate Government-Related and Corporate Index (100% hedged to the New Zealand dollar). The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


Note that even the lowest category does not mean a riskfree investment, and there are other risks that are not captured by this rating.


Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$19 (that is -0.19% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$79 for the year.

Currency hedging

As at 30 June 2023 the fund's exposure to assets denominated in foreign currencies was 101.19%, of which 98.96% was hedged. This means the fund's unhedged foreign currency exposure was 1.05% of the net asset value of the fund. Notes

- 1 These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
- 2 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
