Fund update for the quarter ended 30 September 2022

What is the purpose of this update?

This document tells you how the Ethica Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in a mix of income and growth assets and is designed for investors that want a balanced investment option. A socially responsible fund which excludes assets that do not meet the fund's defined ethical investment standards. Negative annual returns may occur once in every 5-7 years on average.

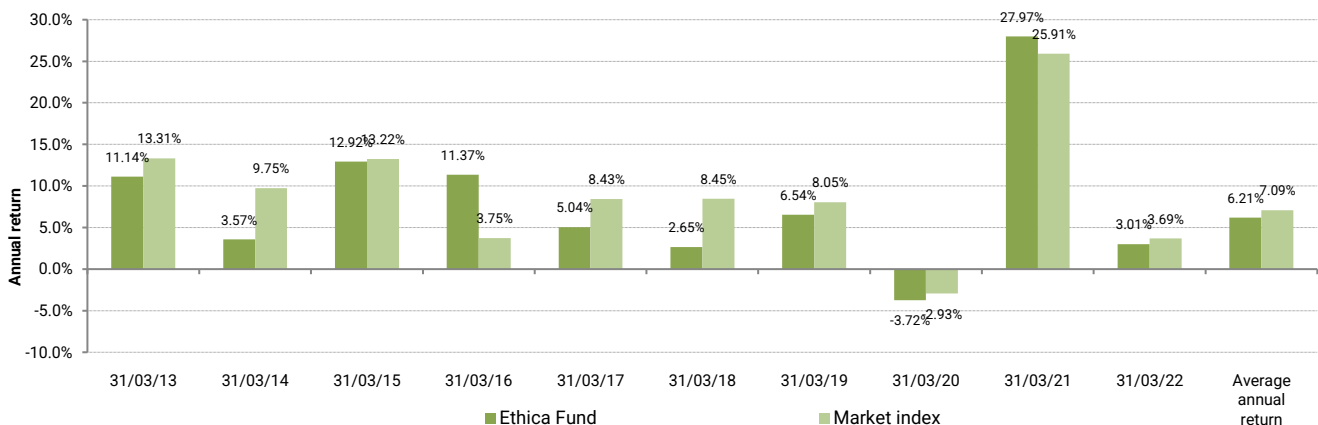
What are the risks of investing?

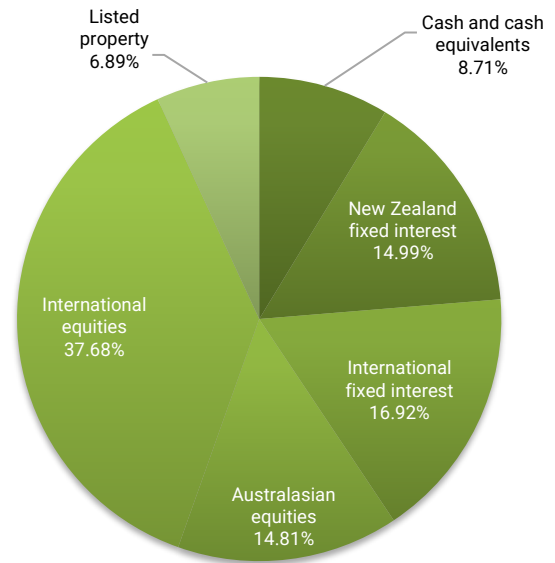
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted but before tax of \$-1073 (that is -10.73% of Jess's initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of \$-1074 for the year.
