Fund update for the quarter ended 30 September 2022

This fund update was first made publicly available on 31 October 2022.

What is the purpose of this update?

This document tells you how the S&P/NZX NZ Government Bond Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The S&P/NZX NZ Government Bond Fund invests in New Zealand bonds and is designed to track the return (before tax, fees and other expenses) of the S&P/NZX NZ Government Bond Index.

Total value of the fund: \$172,267

Number of investors in the fund: 13

What are the risks of investing?

Risk indicator for the S&P/NZX NZ Government Bond Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$886 (that is -8.86% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$898 for the year.

Notes

- We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. This may be shown as 0.00% due to rounding.
