What is the purpose of this update?

This document tells you how the ASB Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ASB Group Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

To provide high total returns allowing for large movements of value up and down. The number of years with negative returns are generally expected to be the highest of the multi-sector funds in the ASB Superannuation Master Trust. We manage asset allocation and currency hedging over the medium to long term relative to the target investment mix. We focus on cost effective management. The ASB Growth Fund invests in income and growth assets with a target investment mix of 20% income assets and 80% growth assets.

What are the risks of investing?

Risk indicator for ASB Growth Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds).

An administration fee may apply. If you are an ordinary member, you will pay an administration fee of 0.50% of the daily average balance of your account. If you are a specified member, the administration fee you pay (if anything) will depend on what has been agreed with your employer – please consult your employer for more information.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$1,854.00 (that is 18.54% of his initial \$10,000). Jason also paid \$54.64 in other charges.* This gives Jason a total return after tax of \$1,799.36 for the year.


*The amount of other charges you pay depends on whether you are an ordinary member or a specified member. Jason is an ordinary member and therefore pays an administration fee of 0.50% of the daily average balance of his account.† If Jason were a specified member, the administration fee he pays (if any) depends on what we have agreed with his employer.

† The administration fee that Jason paid for the year is \$54.64. This assumes that the daily average balance of his account is \$10,927.00.

Currency hedging

As at 30 June 2021 the fund's exposure to assets denominated in foreign currencies was 66%, of which 64% was hedged. This means the fund's unhedged foreign currency exposure was 24% of the net asset value of the fund.
