What is the purpose of this update?




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$1,358 (that is -13.58% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$1,370 for the year.
