What is the purpose of this update?

Description of this fund

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$299 (that is 2.99% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$287 for the year.
