What is the purpose of this update?

Description of this fund

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$293 (that is -2.93% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$305 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 60.00% of the fund's foreign currency exposure. The actual hedging level can be anywhere in the 0% - 120% range. As at 31 Mar 23, 56.79% of the fund's foreign currency exposure was hedged.
