What is the purpose of this update?

Description of this fund

Invests in New Zealand shares and is designed to reflect the return (before tax, fees and other expenses) of the New Zealand share market.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$507 (that is -5.07% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$519 for the year.
