## What is the purpose of this update?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets




## **Example of how this applies to an investor**

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$1,049 (that is 10.49% of Jess's initial \$10,000). Jess also paid \$12 in other charges. This gives Jess a total return after tax of \$922 for the year.
