Fund update for the quarter ended 31 December 2022

What is the purpose of this update?

This document tells you how the Global Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

What are the risks of investing?

Risk indicator for the Global Property Fund

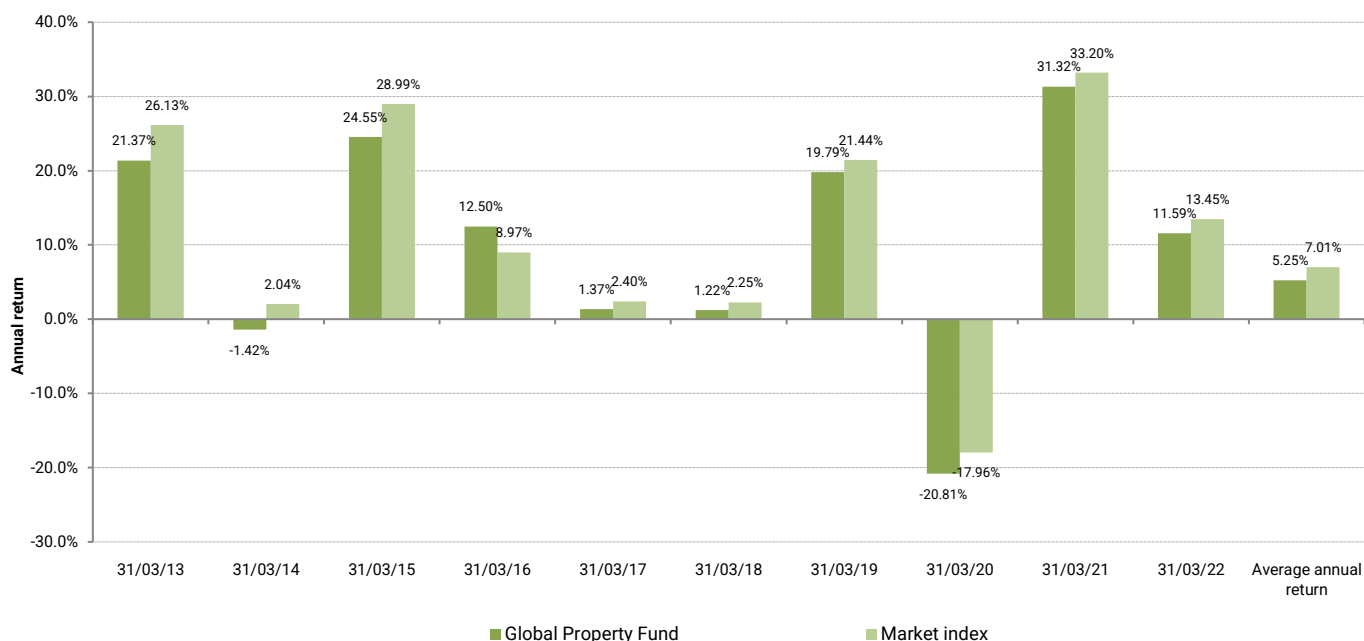
How has the fund performed?

Annual return graph



This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 December 2022.

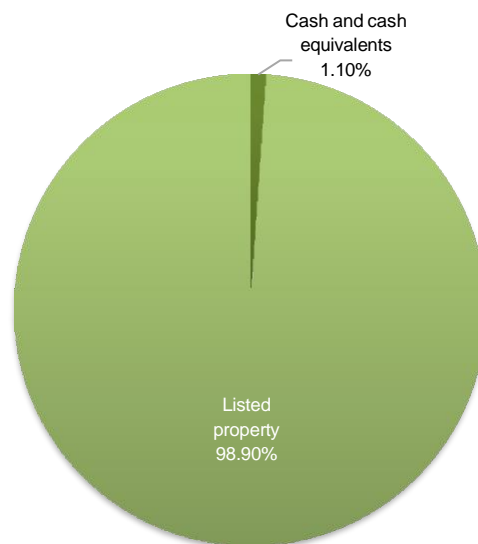
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$2,311 (that is -23.11% of her initial \$10,000). Jess paid other charges of \$30. This gives Jess a total loss after tax of -\$2,341 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100% of the fund's foreign currency exposure. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 December 2022, 98.86% of the fund's foreign currency exposure was hedged.
