What is the purpose of this update?

This document tells you how the SuperLife Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher



Annual return graph


Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted but before tax of \$-1171 (that is -11.71% of Jess's initial \$10,000). Jess paid other charges of \$30. This gives Jess a total loss after tax of \$-1241 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 69% of the fund's foreign currency exposure. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 December 2022, 63.33% of the fund's foreign currency exposure was hedged.
