## Global Property Fund

This is a replacement fund update dated 8 April 2024, which replaces the previous fund update dated 31 October 2022. ### Fund update for the quarter ended 30 September 2022

This fund update was first made publicly available on 8 April 2024.

### What is the purpose of this update?

This document tells you how the Global Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Invests in international property and is designed to reflect the return (before tax, fees and other expenses) on New Zealand and international property markets.

### What are the risks of investing?

#### Risk indicator for the Global Property Fund

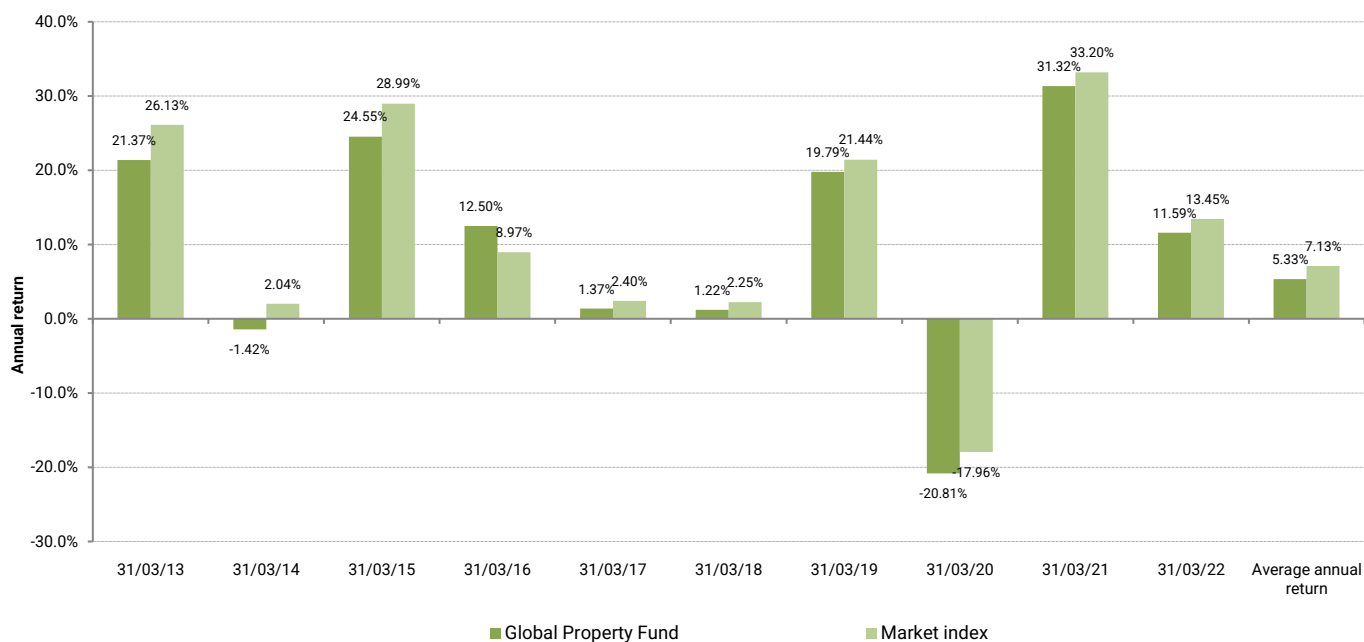

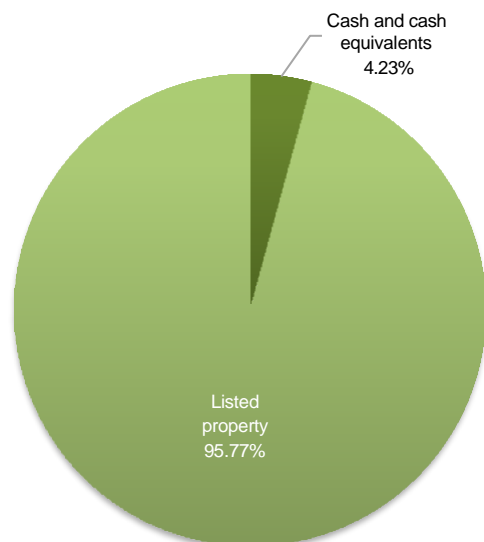
## Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$2,088 (that is -20.88% of her initial \$10,000). Jess paid other charges of \$30. This gives Jess a total loss after tax of -\$2,118 for the year.

## Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100% (although the actual hedging level may differ from this because of cash flow and market movements). As at 30 September 2022, 104.76% of the fund's foreign currency exposure was hedged.
