## What is the purpose of this update?

## What are the risks of investing?

Risk indicator for the S\&P/NZX NZ Government Bond Fund ${ }^{1}$

## What fees are investors charged?

## Example of how this applies to an investor

Jess had $\$ 10,000$ in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of - $\$ 886$ (that is $-8.86 \%$ of her initial $\$ 10,000$ ). Jess paid other charges of $\$ 30$. This gives Jess a total loss after tax of $-\$ 916$ for the year.
