#### Fund update for the quarter ended 31 December 2022

## What is the purpose of this update?

This document tells you how the US Large Value Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Invests in US shares and is designed to track the return (before tax, fees and other expenses) of the CRSP US Large Cap Value Index.

Total value of the fund: \$1,253,739

Number of investors in the fund: 20

## What are the risks of investing?

Risk indicator for the US Large Value Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


## How has the fund performed?


## **Example of how this applies to an investor**

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$390 (that is 3.90% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$330 for the year.

#### **Notes**

- 1 The fund charges were increased on 12 December 2022 by 0.10% per annum of the fund's net asset value.
- We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. This may be shown as 0.00% due to rounding.
- 3 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
