Fund update for the quarter ended 30 September 2017

This fund update was first made publicly available on 24 October 2017.

What is the purpose of this update?

This document tells you how the Overseas Shares (Currency Hedged) Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Overseas Shares (Currency Hedged) Fund is designed to provide a return (after tax, fees and other expenses) that reflects the after-tax return on international share markets of developed economies, excluding the impact of foreign currency movements.

Total value of the fund: \$109,778,567

Number of investors in the fund: 5,296

The date the fund started: 15 October 2007

What are the risks of investing?

Risk indicator for the Overseas Shares (Currency Hedged) Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

Other specific risks

There are other risks that may increase the risk to returns for investors, which are not reflected in the risk indicator. These risks include investment management risk. In particular, while the SuperLife workplace savings scheme's philosophy is that a passive approach to investing will deliver better long-term results, we make some active management decisions. There is a risk that this may result in the fund achieving a return that is lower than its investment objective.


How has the fund performed?

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing money and transferring it to a KiwiSaver scheme other than the SuperLife KiwiSaver scheme). Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$1,745 (that is 17.45% of her initial \$10,000). Jess paid other charges of \$16⁴ (Jess received statements and other SuperLife communications electronically and was not charged the paper statements fee). This gives Jess a total return after tax of \$1,729 for the year.


Paper statements fee

Notes

- 1 On 9 November 2016, the total management and administration charges changed to 0.48% per annum. As a result, the total fund charges will be different in the year to 31 March 2018.
- On 9 November 2016, the administration fee changed to \$12 per annum. As a result, the amount set out in the fees table is made up of 4 months of \$1 per month (when the administration fee was \$12 per annum) and 8 months of \$2.75 per month (when the administration fee was \$33 per annum).
- 3 You will only be charged this fee if you choose to receive statements and other SuperLife communications in paper form.
- This is made up of 2 months of \$2.75 per month (when the administration fee was \$33 per annum) and 10 months of \$1.00 (when the administration fee was \$12 per annum).
