

# SuperLife workplace savings scheme

## SuperLife Balanced Fund

This is a replacement fund update dated 21 December 2023, which replaces the previous fund update dated 10 February 2023. The market index return data in the "How has the fund performed?" section, including the annual return graph, has been updated to show correct market index returns over the relevant periods.

### Fund update for the quarter ended 31 December 2022

This fund update was first made publicly available on 21 December 2023.

### What is the purpose of this update?

This document tells you how the SuperLife Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Invests in a mix of income and growth assets and is designed for investors that want a balanced investment option. Negative annual returns may occur once in every 5-7 years on average.

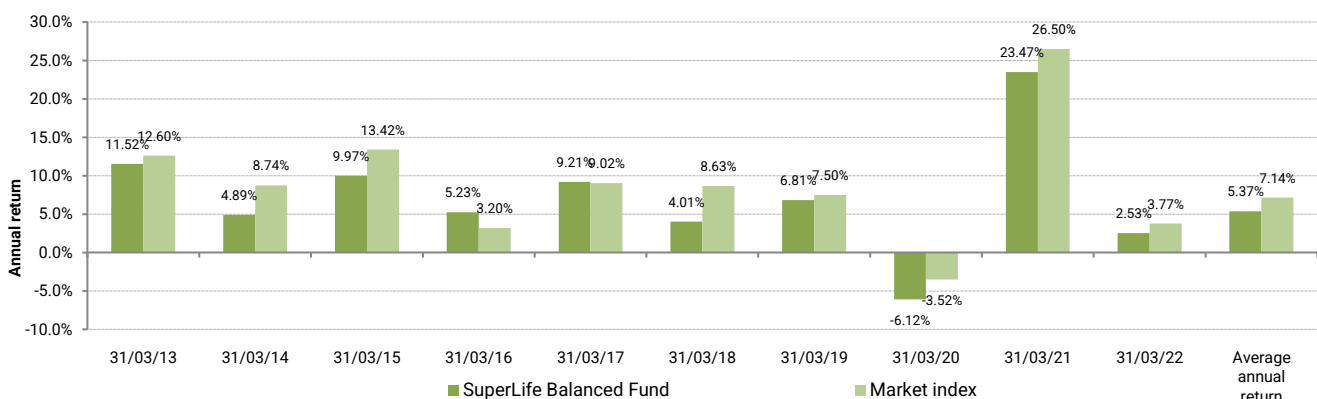
### What are the risks of investing?

#### Risk indicator for the SuperLife Balanced Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

### How has the fund performed?

### What fees are investors charged?<sup>1</sup>

Investors in the SuperLife Balanced Fund are charged fund charges. In the year to 31 March 2022 these were:

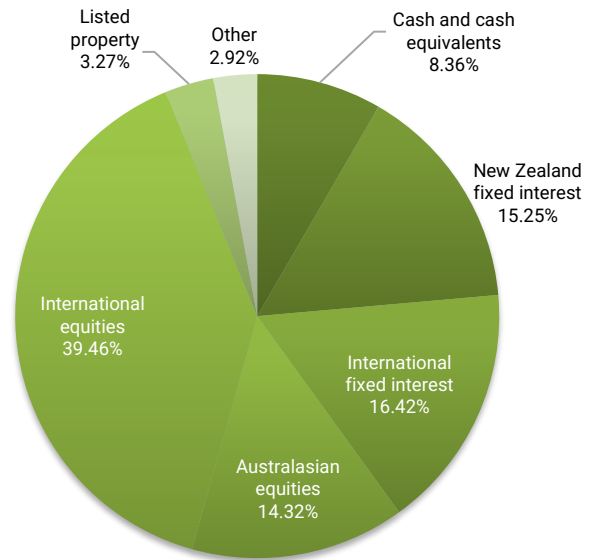
### Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted but before tax of \$-1026 (that is -10.26% of Jess's initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of \$-1078 for the year.

## Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 75.50% of the fund's foreign currency exposure. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 December 2022, 70.20% of the fund's foreign currency exposure was hedged. ## Notes

- The fund charges were increased on 12 December 2022 by 0.10% per annum of the fund's net asset value.
- We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. This may be shown as 0.00% due to rounding.
- The 'other' category refers to an investment in infrastructure. The underlying investments are infrastructure securities listed in developed countries.
