# **SuperLife Conservative Fund**

This is a replacement fund update dated 21 December 2023, which replaces the previous fund update dated 10 May 2023. The market index return data in the "How has the fund performed?" section, including the annual return graph, has been updated to show correct market index returns over the relevant periods.

## What is the purpose of this update?

This document tells you how the SuperLife Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# **Description of this fund**

Invests mostly in income assets and is designed for investors that want a conservative investment option. Negative annual returns may occur once in every 7-10 years on average.

## What are the risks of investing?

#### Risk indicator for the SuperLife Conservative Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



## How has the fund performed?

#### Annual return graph





This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 March 2023.

Small differences in fees and charges can have a big impact on your investment over the long term.

### **Example of how this applies to an investor**

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted but before tax of \$-327 (that is -3.27% of Jess's initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of \$-356 for the year.

#### **Currency hedging**

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 88.00% of the fund's foreign currency exposure. The actual hedging level can be anywhere in the 0% - 120% range. As at 31 Mar 23, 80.97% of the fund's foreign currency exposure was hedged.
